- Being software configurable such that a single hardware SKU can serve in a Point-to-Point (PtP) or Point-to-Multipoint (PtMP) configuration (and as either a base station or a subscriber unit in a PtMP setting)
- Enabling mobility ensuring uninterrupted connectivity for a subscriber unit moving at up to 120 miles per hour and even roaming from one base station to another
- Being certified as FIPS 140-2 level 2 compliant providing ultra-secure connectivity
